basketballscotland recognises that there are many avenues, outside of the basketball pathway, by which individuals may have developed their coaching skills. Coaches may have gained coaching skills abroad or through working in other sports. **basketball**scotland values these skills and welcomes coaches from different backgrounds into our sport in Scotland. In order to assist these coaches, we offer a number of routes to recognise achievement, valuing it against the current **basketball**scotland pathway. Please note that the examples are not exhaustive and that each application is evaluated individually.

Who should apply?	Anyone who has gained qualifications abroad & has been coaching for a minimum of 6 months.	Anyone who wishes to map their current skills and experience against the pathway for basketball. E.g. those who have completed qualifications in other sports, college or university which are sport related and may only need to complete certain units.	Former athletes or anyone who has assisted in coaching informally. Coaches from other sports at a high level who also have proven knowledge of basketball.

What is the outcome if successful?	If successful, in order to coach at the same level as in your home country, no further formal training will be required. However, CPD may be required.	Successful candidates will be offered assessment in the remaining units of the appropriate qualification. On successful completion of the assessments the qualification will be awarded.	If successful, you will be awarded the appropriate qualification. However, CPD may be required.
