- Presenting quarterly management accounts to the Board (to be prepared by Head of Operations)
- Presenting annual accounts to the Board and the membership (to be prepared by Head of Operations)
- To maintain an ongoing understanding and overview of the annual budget and long-term financial plan of **basketball**scotland
- To chair the Finance Sub-Committee of the Board
- To provide advice, when required, to the Board on specific finance related issues
- To provide operational support and guidance, when requested, to the professional staff responsible for finance

- Any other related duties as deemed necessary from time to time.
